3. The School will assign you a pre-registration number at soon as we receive copy of the bank transfer of 850€ (Euros) in the aforementioned account. Said pre-registration number will determine the order of the students 'acceptance in the school course/s.
4. The final enrollment will be conditioned to the registering of a minimum group of 5 students.
