2. At the time of the student's enrollment, the amount of this pre-registration will be deducted from the registration fee. In case of deciding not to register, the applicant will not be entitled to the refund of said amount of 200€.
3. The final enrollment will be conditioned by the maximum number of available spaces authorized by the School as provided in Royal Decree 303/2010 of March 15, which establishes the official requirements for educational centres providing education in the Arts (as published on BOE of 9 April).
4. The School will assign you a pre-registration number at soon as we receive copy of the bank transfer of 200€ (Euros) in the aforementioned account. Said pre-registration number will determine the order of the students 'acceptance in the school course/s.
